- 2. Water and debris (leaves, sticks, etc.) must be removed from cover to avoid a \$100.00 extra service fee that will automatically be added to opening if not performed by homeowner.
- 3. Please insure that electricity is turned on to the pool equipment.
- 4. Additional charges will be incurred for excessive cleaning and multiple trips.
